Proof of evidence will be required when necessary. If the number of applicants who have the same priority exceeds the target enrolment capacity, draw lots will be arranged for the selection process.
2. No School bus service will be provided after the activity. Please make proper arrangement for your child/ward to go home.
3. If your child/ward take leave on a particular activity date, you must notify the teacher-in-charge through the school handbook in advance.
4. If your child /ward is absent without reasons or notification in advance, the school has the discretion to stop him/her from joining other after-school activities.
